COOKIE POLICY

This Cookie Policy was last updated on 【11 September 2025】

This Cookie Policy applies to the subsidiaries, affiliates, and other entities controlled by XCMG Construction Machinery Co., Ltd. as identified in Appendix A (List of XCMG Data Controllers/Legal Entities) (collectively referred to as "XCMG"). This Cookie Policy applies to all XCMG websites and mobile applications ("XCMG Platforms") to the extent that XCMG is not offering a particular privacy information on such website or app. When you visit the XCMG Platforms and provide your consent, we use the cookies and other similar tracking technologies you agreed with to enhance the XCMG Platforms functionality, performance, measure website traffic.

What are cookies?

A cookie is a small text file that a website stores on your computer or mobile device when you visit the site.

- First party cookies are cookies set by the website you're visiting. Only that website can read them. In addition, a website might potentially use external services, which also set their own cookies, known as third-party cookies. Cookies normally work by assigning a unique number to your device and are stored on your browser by the websites that you visit as well as third party service providers and partners to those websites.
- Persistent cookies are cookies saved on your computer and that are not deleted automatically when you quit your browser, unlike a session cookie, which is deleted when you quit your browser.

The purpose of cookies may differ by cookies. This is why we have grouped cookies by their purpose of data processing:

The purpose of cookies that we call "Visitor Preferences" is to operate our website safely and securely ant to provide you with a certain browning comfort, e.g. as we enable the site to remember your preferences (such as user name, language, etc.) for a certain period of time.

That way, you don't have to re-enter them when browsing around the site during the same visit.

The other kind of cookies, called "Operational Cookies" covers all kinds of technologies that are not "Visitor Preferences". This can, for instance, be tracking

or profiling technologies. Please read the respective sections of this cookie policy for further information.

How do we use cookies?

The 2 types of first-party cookie we use are to:

- visitor preferences
- make our websites operational

Visitor preferences

These are set by us and only we can read them. They remember:

- your cookie-preferences per your settings in our consent-management if you have agreed to (or refused) cookies and whether you took notice of this site's cookie policy
- if you have already replied to our survey pop-up (about how helpful the site content was) so you won't be asked again
